**Contract Terms & Conditions**

Exhibitor assumes entire responsibility and hereby agrees to protect, indemnify, defend and save the Vermont Comic Con and Sheraton Hotel and all their employees and agents harmless against all claims, losses and damages to person or property, governmental charges and or fines and attorney fees arising out of or caused by exhibitors installation, removal, occupancy or use of the exhibition premises or any part thereof. Exhibitors agree to hold harmless the Vermont Comic Con and any of its production partners from loss or damage of merchandise or injury sustained during attendance at its events. The Vermont Comic Con takes no responsibility for items lost or stolen: it is up to vendors to carry insurance for their goods.

Payment is due when contract is sent unless arrangements have been made. We can not hold floor space without payment.

Exhibitors will limit their display to the rented table space and a reasonable distance behind that space that is deemed "theirs" and will not alter the convention floor plan in any way. No Exhibitor will be or is allowed to have any item(s) in the aisle space of the convention floor without PRIOR approval of the authorized convention liaison.

Exhibitors will not and are not permitted to affix anything to the convention room walls. Any damage to the facility NOT reported to the Vermont Comic Con and/or Sheraton Hotel before 10:00AM EST on the morning of the aforementioned show, will completely be the responsibility of the exhibitor occupying the space; and said exhibitor will be held personally responsible for said damage.

Table rentals are for exhibitors only.

Exhibitors requiring electrical, phone, Internet, cable and/or other communications connections need to contact the Vermont Comic Con prior to the show date and make the appropriate arrangements.

Exhibitors will not bring any gambling devices (EX: grab bags, dice games, games of chance, card dispensing machines etc.) to be used on or near the premises of the Vermont Comic Con and Sheraton Hotel.

Due to space restrictions in exhibition areas, all exhibitors are limited to the amount of workers/help. The limit is 2 persons per paid table. No exceptions. Workers/Help found in violation will be asked to leave, unless entry fee is paid.

Vermont Comic Con strictly prohibits promotion of genre events without pre-written confirmation. Although we often allow this to occur at our sole discretion, if the event you wish to promote is directly competitive to existing or planned Vermont Comic Con events, unfortunately we cannot allow promotion of said conventions. Distribution of promotional flyers for comic book or other genre conventions without permission will result in your booth being closed without refund.

Load in will begin Saturday & Sunday at 6 am and complete at 10 am. All vehicles must be removed for the loading dock by this time.

Vermont Comic Con has the right to remove any offensive material displayed. No nudity is to be displayed at any Exhibitor's table. Sale of weapons is strictly prohibited.

The tables you purchase are for your use ONLY. NO SUBLETTING and/or RESELLING of tables will be allowed.

Vermont Comic Con only allows the sale of licensed merchandise (including videotapes) at its events. Exhibitors are responsible for the legality of the items they sell, as well as government and/or tax licenses, and insurance. See Anti-Bootleg policy below!

All exhibitors must be packed up and all products and materials owned by said dealer must be entirely removed from the convention space by **7:00 PM EST on Sunday August 27, 2017.**

Tables will not be refunded unless show is cancelled.

VERMONT COMIC CON RESERVES THE RIGHT TO DENY EXHIBITOR ACCESS TO ANY EVENT IF THE COMPANY FEELS THAT PARTICIPATION BY A GROUP OR INDIVIDUAL WILL HARM THE EVENT OR OUR COMPANY IN ANY MANNER. VERMONT COMIC CON WILL BE THE FINAL ARBITER IN THESE CASES. THIS INCLUDES SUB-LETTING SPACE FOR THE SHOW.
